WHEREAS, the program's objective is to support the establishment or continuation of a County Re-entry Task Force to enhance the community re-entry process and better align it with evidence-based practices, serving offenders returning to the community from prison, and

WHEREAS, there is no County match required for this grant program, and

WHEREAS, the Criminal Justice and Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature be authorized to execute a Contract (NYS Comptroller's No. C490000), and any future amendments thereto, with the New York State Division of Criminal Justice Services for funding in the amount of \$100,000.00, for the establishment or continuation of a County Re-Entry Task Force for the period October 1, 2009 through September 30, 2010, in the form as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney, and, be it further
