Parete and Legislators Bartels, Donaldson, Kraft, Busick, Gerentine and Harris) and The Ways and Means Committee (Chairman Lomita and Legislators Bartels, Berardi, Gregorius, Provenzano, Zimet, Cummings, Gerentine and Noonan) offer the following:

WHEREAS, the Ulster County Sheriff has requested \$10,950.00 to process the payment for signs and safety, general office and other law enforcement that are necessary to open the Ulster County Law Enforcement Center, and

WHEREAS, the Ulster County Sheriff's Jail Division was reimbursed \$45,937.50 during the year 2005 from the Law Enforcement Center Capital Project for Capital Expenditures made from the Jail Operating Budget, and

WHEREAS, the Ulster County Sheriff requests that the \$10,950.00 be appropriated from the Contingent Account and transferred to the Jail Division to process the payment for signs and safety, general office and other law enforcement equipment, and

WHEREAS, the Law Enforcement Center Project Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.
