The Legislative Programs, Education and Community Services Committee (Chairman Harris and Legislators Belfiglio, Hayes, Terrizzi, Donaldson, Gregorius and Madsen) offers the following:

WHEREAS, performing arts are an important component of our cultural heritage, and the many performances arranged by the Ulster Performing Arts Center attract the Hudson Valley County residents as well as travelers to see a broad range of entertainment for the community, and

WHEREAS, pursuant to County Law Section 224 (13), the Ulster County Legislature appropriated to the Ulster Performing Arts Center the sum of \$18,750.00 in the 2011 Ulster County Budget for the maintenance of facilities, and

WHEREAS, pursuant to County Law Section 224 (13), in order to receive such funds, the Ulster Performing Arts Center must submit to the Ulster County Legislature a verified accounting of disbursements to be undertaken, and to the Commissioner of Finance, a Memorandum of Receipt signed by the principal officer, and

WHEREAS, the Ulster Performing Arts Center will receive payment in the amount of \$18,750.00, in accordance with the terms specified in an agreement with the County of Ulster and the Ulster Performing Arts Center and will return any unexpended funds as of December 31, 2011, along with a certified accounting of expenditures to the Commissioner of Finance, and

WHEREAS, the Legislative Programs, Education and Community Services Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Comptroller and/or any and all officers of the County of Ulster, their agents and representatives, shall be allowed full access upon reasonable notice and at reasonable times to the books, papers, records and premises of the Ulster Performing Arts Center, during the period that this resolution is in effect for
