WHEREAS, the District Attorney has received notice of award for a grant from the New York State Division of Criminal Justice Services for the Domestic Violence Program and has requested that the Chairman of the Ulster County Legislature be authorized to execute an agreement and any amendments to the agreement, Contract No. T088739 for a Local Government Initiative No. LOG08088739, in the amount of \$37,500.00 (or less due to New York State budget reductions), for the period commencing April 1, 2008 and ending December 31, 2009, and

WHEREAS, the funds from this grant will be used to assign and train an Assistant DA (ADA) to specialize and focus in the prosecution and investigation of Domestic Violence (DV) offenses for the Specialized Domestic Violence Court within the County and to enhance the prosecution of domestic violence offenders to provide training and community awareness of the impact of domestic violence, and

WHEREAS, the Criminal Justice and Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and approved said request with a majority of members voting approval, now, therefore, be it
