WHEREAS, Subdivision 6 (b) of Section 65 of Social Services Law further provides that expenditures made pursuant to this Section, subject to State reimbursement, shall be a charge on, and shall be reimbursed to the County by the Towns and the City of Kingston, now, therefore, be it
