RESOLVED, that the Ulster County Soil and Water Conservation District shall render a true and accurate report of its operations for the year 2010 prior to the release of any authorized funding for 2011, and, be it further

RESOLVED, that no County money be paid to the District until a Memorandum of Receipt signed by the Chairman of the District Directors, agreeing to comply with the terms of this Resolution, is delivered to the Commissioner of Finance, and, be it further

RESOLVED, that said Ulster County Soil and Water Conservation District shall render a verified account of disbursements with certified vouchers attached and refund any unused amount on or before the 31st day of December 2011, and, be it further
