WHEREAS, pursuant to General Municipal Law, Section 119-n(a) the definition of a municipality includes a school district, and

WHEREAS, Ulster County desires to support an educational anti-drug and alcohol free event during the 2010 calendar year, by the Onteora Central School District, and

WHEREAS, to compensate the school district for supplying and organizing a safe environment for their Belleayre Bash, an alcohol and drug free after graduation event on June 25, 2010, and

WHEREAS, the amount paid to the Onteora Central School District by Ulster County for this event will not exceed \$700.00 (Seven hundred and 00/100 Dollars), and

WHEREAS, the Legislative Programs, Education and Community Services Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an Inter-Municipal Agreement, and any amendments thereto, with the Onteora Central School District for the educational anti-drug and alcohol free school event during the 2010 calendar year, in the form as filed with the Clerk of the Ulster County Legislature or as modified and approved by the County Attorney,
