WHEREAS, this resolution has been submitted by the County Executive on behalf of the Ulster County Sheriff, and

WHEREAS, the Ulster County Sheriff has received a new contract (Contract number C200397) from the New York State Unified Court System for Court Attendants to assist in County and Supreme Courts for the term April 1, 2009 through March 31, 2014, and

WHEREAS, New York State will reimburse Ulster County for 100% of the expense of these attendants, not to exceed \$45,000.00 for the initial period April 1, 2009 through March 31, 2010 (the first year of this five-year agreement), and

WHEREAS, the 2010 Ulster County Budget reflects revenue from this source, and related appropriations in the amount of \$65,010.00, and therefore said Budget will require an amendment, and

WHEREAS, the Law Enforcement and Public Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an agreement, and any amendments thereto, with the New York State Unified Court System for the period April 1, 2009 through March 31, 2014, and to accept the initial year funding of \$45,000.00, in the form as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney, and, be it further
