WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Employment and Training, and

WHEREAS, the Director of the Ulster County Department of Employment and Training (OET) requests that the Chairman of the Ulster County Legislature be authorized to execute an agreement and that the 2011 Ulster County Budget be amended to accept an additional \$2,500.00 in funding as an Employment Network under the Ticket to Work Program through the Social Security Administration, and

WHEREAS, the Department of Employment and Training will provide employment services to Social Security beneficiaries with disabilities, and will earn outcome-milestone payments for placing these individuals in employment that meets identified criteria, and

WHEREAS, the Department of Employment and Training will provide such services as an Employment Network for an undetermined timeframe and as part of the operation of the Ulster Works OneStop Center, and with an estimated earnings in Year 1 of \$2,500.00, and

WHEREAS, the Health and Human Services Committee has met and reviewed said request with a majority of its members voting approval, now, therefore, be it

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of its members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an agreement to accept an additional \$2,500.00 in funding as an Employment Network under the Ticket to Work Program through the Social Security Administration and that the 2011 Ulster County Budget is hereby amended as follows:
