# Resolution No. 44 February 15, 2011

Amending The 2011 Ulster County Budget - Purchase Of Public Transportation Equipment – Security Camera, Bus Route Signs, Bicycle Racks And Bus Shelters – Department Of Public Transportation (Ulster County Area Transit)

The Economic Development and Tourism Committee (Chairman Maloney and Legislators Aiello, Frey, Hayes, Sweeney, Terrizzi, Donaldson, Loughran and Rodriguez) offers the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Public Transportation, and

WHEREAS, a Federal Transit Grant in the amount of \$1,240,000.00 (Federal 80%, State, 10%, and County, 10%) for public transit capital expenditures was awarded on October 1, 2010, to be used commencing December 15, 2010 and ending June 15, 2012. Such award included public transit vehicles and public transit equipment expenditures, and has been identified as Project Number NY-90-X654-00, and described in the Catalogue of Federal Domestic Assistance, Number 20.507, as a Federal Transit Capital and Operating Assistance Formula Grant, and

WHEREAS, the 2011 Ulster County Area Transit (UCAT) Budget included a vehicle allocation for the purchase of two 30 foot transit buses at \$375,000.00 each, a maintenance support vehicle at \$35,000.00 and a para-transit van at \$65,000.00, for a total of \$850,000.00, and

WHEREAS, bids were received for \$790,000.00 for the above described vehicle allocation component of \$850,000.00 and there now remains \$60,000.00 of uncommitted funds (\$48,000.00, Federal; \$6,000.00, State, and \$6,000.00, County), and

WHEREAS, the balance of the grant may be used for public transit equipment, and UCAT desires to purchase security cameras for \$250,000.00, bus route signs, for \$75,000.00, bicycle racks for \$15,000.00, and bus shelters for \$50,000.00, for a total estimated cost of \$390,000.00, and

WHEREAS, the Director of Ulster County Area Transit requests that the 2011 budget be amended to reallocate the \$60,000.00 remaining from public transit vehicle purchases, and add \$297,000.00 in new State and Federal aid and \$33,000.00 budgeted UCAT funds (the local matching County share) for these public transit equipment purchases, and

WHEREAS, the Economic Development and Tourism Committee has met and reviewed said funding with a majority of members voting approval, and
