WHEREAS, the Ulster County Legislature transferred approximately 6% or \$37,333.00 of such funds into a contingency reserve to be reallocated to the Environmental Management Council upon request with sufficient justification for departmental needs, and

WHEREAS, the Chairman of the Ulster County Environmental Management Council requests that the \$37,333.00 be reinstated and transferred from the Contingent Account to Other Miscellaneous Contractual Expenses for contracting education and training to meet the mandated requirements of the Ulster County MS4 Stormwater Program, and

WHEREAS, the Environmental Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.
