Authorizing Agreement With Town Of Hardenburgh For Maintenance Of County Road Numbers CR102, CR7A And CR145

The Public Works and Capital Projects Committee (Chairman Loughran and Legislators Cahill, Decker, Lomita, Fabiano, Felicello and Roberts) and Legislators Gregorius and Shapiro offer the following:

WHEREAS, County Road Numbers CR102 (6.2 miles), CR7A (3.77 miles) and CR145 (1.73 miles) are so located that it is impossible to maintain said roads without proceeding on a circuitous route through Delaware County, thereby greatly increasing the cost of the maintenance work performed, and

WHEREAS, the Town of Hardenburgh, at the request of the Ulster County Commissioner of Highways and Bridges, has agreed to perform normal maintenance for the sum not to exceed \$53,060.00 for the full 11.7 miles, which represents a 2% increase from the year 2007 agreement, and

WHEREAS, the Public Works and Capital Projects Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the County enter into an agreement with the Town of Hardenburgh with respect to County Road Numbers 102, 7A and 145, whereby the Town will furnish all labor, equipment and materials necessary to maintain such roads by plowing snow, sanding and salting, hauling sand, cutting grass and brush, cleaning culverts and ditches and patching said roads and generally keeping them in a neat and safe condition, and for which the Town will be paid the sum not to exceed \$53,060.00, payable in two (2) equal installments, with the first payment due on April 1, 2008 and the second on October 1, 2008, said agreement to commence on January 1, 2008 to continue for a term of one year until midnight December 31, 2008, and with such payment to be rendered upon certification of completed work by the Town Highway Superintendent, and

FURTHER RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute, on behalf of the County, an agreement with respect to the foregoing in the form, as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney,
