WHEREAS, the Federal Byrne Justice Assistance Grant (JAG) Project No. BJ06-1088-D00, is a Federal Pass-thru DCJS State Project No. BJ05909830 which will be administered over an eighteen month period, starting January 1, 2007 through June 30, 2008, and

WHEREAS, this project will utilize \$5,556.00 of reallocated and unexpended Operation IMPACT III, funds, which are to be utilized by June 30, 2007, and

WHEREAS, Operation IMPACT III funds will be used for the room preparation and training fees, upon approval of the New York State Division of Criminal Justice Services, and

WHEREAS, each County dollar spent under the Federal Byrne Justice Assistance Grant (JAG) Project and the Operation IMPACT III initiative is 100% reimbursable by the New York State Division of Criminal Justice Services, and

WHEREAS, the Criminal Justice and Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.
