WHEREAS, the cost overruns and litigation expenses related to the Ulster County Law Enforcement Center (UCLEC) created financial hardships to all taxpayers of Ulster County, and

WHEREAS, the taxpayers of Ulster County will be paying as much as \$6 million in "jail taxes" annually during the next 20 years, and

WHEREAS, the cost overruns and other expenses related to the building of the UCLEC have been investigated, resulting in a recommendation that Ulster County seek redress for losses incurred, and

WHEREAS, cost overruns and other related expenses have been litigated in United States Federal Court and said matter is currently pending therein, and

WHEREAS, the litigation may result in a sum of money being awarded to Ulster County due to the negligence and/or breach of contract of certain contracted agents of the County, and

WHEREAS, the long term financial future of Ulster County is unknown and uncertain, and

WHEREAS, the Ulster County Legislature pledges to the public that reducing long term public debt is its highest priority and a sensible financial policy decision, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Ulster County Legislature affirms all proceeds from any financial judgment, reimbursement, settlement or award resulting from litigation, mediation, trials or agreements shall be applied solely to V3-4450-2701 (Debt Service Fund) intended to eliminate debt as it relates to all phases of Capital Project No. 236 Construction of a New Law Enforcement Facility,
