WHEREAS, this resolution has been submitted by the County Executive on behalf of the Ulster County Department of Public Works (Highways and Bridges), and

WHEREAS, the Commissioner of Public Works has prepared the 2010 Bridge Replacement Program which was approved in the 2010 – 2015 Capital Program, and

WHEREAS, it is now necessary to establish capital projects and request funding to reconstruct various County Owned Bridges and Box Culverts, and

WHEREAS, the Commissioner of Public Works requests that the following capital projects be established and funded as follows:

Capital Project No. 330	Zena Box Culvert Town of Woodstock	\$200,000.00
Capital Project No. 331	Ulsterville-County Line Bridge Town of Shawangunk	\$300,000.00
Capital Project No. 332	Oliverea Bridge Town of Shandaken	\$350,000.00

WHEREAS, based upon the examination of the Ulster County Legislature, and pursuant to Part 617 of the implementary regulations pertaining to Article 8 of the State Environmental Quality Review Act (SEQRA), it has been determined that the adoption of this proposed Local Law constitutes a Type II action as defined under 6 NYCRR 617.5(c) (1) and 617.5(c) (2) and requires no further review under SEQRA, and
