

Resolution No. 5 January 2, 2013

Commencing The Process to Extend The Additional Sales Tax Rate Of One Percent As Previously Authorized By Chapter 200 Of The Laws Of 2002 For An Additional Period Of At Least Twenty-Four Months

Chairman of the Ways and Means Committee, Richard A. Gerentine, and Deputy Chairman Donald J. Gregorius offer the following:

WHEREAS, the County's burden of mandated costs for Medicaid, Handicapped Children's Services, Public Assistance, and in other areas, has risen in recent years and will continue to do so into the foreseeable future; and

WHEREAS, strict austerity measures undertaken in operations of the county government have substantially mitigated but not eliminated the financial burden of mandates on Ulster County; and

WHEREAS, the financial constraints of the past several years have required some tax increases for County purposes though it has long been and continues to be the policy of this government, to minimize such increases; and

WHEREAS, though no tax increase is desirable, unlike the property tax, the sales tax is linked to people's behavior as consumers and is paid in part by persons who are not County residents or property owners; and

WHEREAS, the additional sales tax rate of one percent as authorized by Chapter 200 of the Laws of 2002 and amended in 2003, 2005, 2007, 2009 and 2011 will expire on November 30, 2013; and

WHEREAS, the Ulster County Legislature wishes to ease the burden on the County property taxpayer by continuing the additional sales tax rate of one percent, as authorized by Chapter 200 of the Laws of 2002 as amended in 2003, 2005, 2007, 2009 and 2011 for at least the twenty-four month period commencing December 1, 2013; now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to request the New York State Legislature to commence the process of extending the Ulster County additional sales tax rate of one percent, as authorized by Chapter 200 of the Laws of 2002 as amended in 2003, 2005, 2007, 2009 and 2011 for at least the twenty-four month period commencing December 1, 2013; and, be it further
