WHEREAS, the Ulster County Legislature adopted the Capital Program for the Years 2011 to 2016 which included the recommendation to purchase five police vehicles and five packages of police vehicles software and equipment at a cost of \$209,885.00 to supplement the aging fleet of existing vehicles, and

WHEREAS, the County Executive now, after a thorough review and recommendations by the Fleet Manager, requests that Capital Project No. 337 be established and funded to purchase four marked patrol cars at \$122,000.00, one SUV at \$34,500.00 and five packages of police vehicles software and equipment at \$53,385.00 for a total cost of \$209,885.00, and

WHEREAS, the vehicles purchased will replace vehicles that have high mileage or have been damaged beyond reasonable repair and have been determined to be unsafe, and

WHEREAS, the Law Enforcement and Public Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Public Works and Capital Projects Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it
