

Establishing Capital Project No. 328 For The Purchase Of Vehicles For Various County Departments For The Year 2010 – Amending The 2010 Ulster County Capital Project Fund Budget

The Budget and Finance Committee (Chairman Gerentine and Legislators Bernardo, Frey, Hansut, Harris, Maio, Maloney, Gregorius, Lomita, Provenzano and Sheeley) offers the following:

WHEREAS, the Ulster County Legislature adopted the Capital Program for the Years 2010 to 2015 which included the recommendation to purchase thirteen vehicles at a cost of \$303,500.00 to supplement the aging fleet of existing vehicles, and

WHEREAS, the County Executive now, after a thorough review and recommendations by the Fleet Manager, requests that Capital Project No. 328 be established and funded to purchase six vehicles at a cost of \$170,500.00.00, and

WHEREAS, the recommended purchases include five marked patrol cars (\$145,000.00) for the County Sheriff and one van (\$25,500.00) for the Veterans Agency for a total costs of \$170,500.00, and

WHEREAS, the vehicles purchased will replace vehicles that have high mileage or have been damaged beyond reasonable repair and have been determined to be unsafe, and

WHEREAS, any vehicles which will be inspected and repaired, and if determined in reasonably safe condition, will be transferred to other County agencies, thereby reducing the County's fleet purchase costs, and

WHEREAS, based upon the examination of the Ulster County Legislature, and pursuant to Part 617 of the implementary regulations pertaining to Article 8 of the State Environmental Quality Review Act (SEQRA), it has been determined that the adoption of this proposed Local Law constitutes a Type II action as defined under 6 NYCRR 617.5(c)(25) and 617.5(c) (27) and requires no further review under SEQRA, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the 2010 Ulster County Capital Fund Budget is hereby amended as follows:
