WHEREAS, the United States Department of Justice, Office of Community Oriented Policing, has offered a grant in the amount of \$246,661.00 to be used for Mobile Data Technology Sharing, and

WHEREAS, a previous federal grant in the amount of \$113,349.00 allowed for the development of the Ulster County Sheriff's Mobile Data Computer System (MDC), and

WHEREAS, the grant for this project will provide for the integration of technology information for Ulster County municipalities, including towns, villages and the City of Kingston into the existing Sheriff's Mobile Data Computer System (MDC), with funding for laptop computers, mobile digital video recording units and related equipment for the patrol cars, and

WHEREAS, there is no County funding required for this grant award, and

WHEREAS, the Criminal Justice and Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an appropriate agreement and accept said grant from the United States Department of Justice, Office of Community Oriented Policing as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney, and
