WHEREAS, the Personnel Director has reviewed the appropriate job class questionnaire and new position duties statement submitted by the Commissioner of the Department of Social Services and has by Order and Determination #8325 dated February 20, 2009 reclassified the vacant Principal Social Welfare Examiner (Grade 14) (Full-time) position to Social Welfare Examiner (entry grade 9 trainee, grade 10 full performance) and has created a Social Welfare Examiner (Entry Grade 9 trainee, Grade 10 full performance) (Full-time) position pending Legislative approval and subsequently has allocated such to the competitive class of the classified civil service, and

WHEREAS, the Human Development and Personnel Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it
