WHEREAS, this \$359,235.00 amount includes programs totaling \$73,466.00 administered by municipalities other than the County (e.g., Towns, Villages and/or City) and reimbursement for which is provided directly from New York State to those municipalities, and

WHEREAS, the County portion of this allocation is \$285,769.00, and

WHEREAS, the Resource Allocation Plan covers Youth Development and Delinquency Prevention, Special Delinquency Prevention, and Runaway Homeless Youth Act programs, and

WHEREAS, the Ulster County Youth Board has met and reviewed all submitted proposals and program monitoring documents, and the majority of members have voted approval of the proposed 2010 Resource Allocation Plan, and

WHEREAS, the Health and Human Services Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Ulster County Legislature hereby approves the Ulster County Youth Bureau's 2010 Resource Allocation Plan in the amount of \$359,235.00, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney, and be it further

RESOLVED, if funding for this plan is eliminated, County participation will be reviewed by the Budget and Finance Committee,
