Authorizing The Chairman Of The Ulster County Legislature To Enter Into A Lease Agreement With Tivoli Management Corporation For The Department Of Health Satellite Office In Highland – Department Of Public Works (Buildings And Grounds)

The Public Works and Capital Projects Committee (Chairman Fabiano and Legislators Felicello, Maloney, Roberts, Hochberg, Loughran and Provenzano) offers the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Public Works (Buildings and Grounds), and

WHEREAS, the present lease agreement with Tivoli Management Corporation for the Department of Health satellite office at 570 Rt. 299, Highland, New York, will expire on March 30, 2010, and

WHEREAS, the Commissioner of Public Works has requested that the Chairman of the Ulster County Legislature be authorized to execute a lease agreement with Tivoli Management Corporation for the continued use of the office space for a three-year term from April 1, 2010 to March 31, 2013, at an annual cost of \$38,400.00 (3,200 square feet or \$12.00 per square foot) with no increase from the previous five year lease, and

WHEREAS, the Public Works and Capital Projects Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to enter into a lease agreement with Tivoli Management Corporation for office space for a satellite office of the Department of Health located at 570 Rt. 299, Highland, New York, for a three-year term from April 1, 2010 to March 31, 2013, at an annual cost of \$38,400.00, in the form as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney,
