WHEREAS, this resolution has been submitted on behalf of the Department of Public Works, and

WHEREAS, the present lease agreement with KEMP Properties for the Department of Health satellite office located at 123 Partition Street, Saugerties, New York, will expire on April 30, 2010, and

WHEREAS, the Commissioner of Public Works has requested that the Chairman of the Ulster County Legislature be authorized to execute a lease with KEMP Properties for a term of five years, commencing May 1, 2010 and ending April 30, 2015, at an annual cost of \$17,325.00 (1,575 square feet or \$11.00 per square foot) with no increase from the previous five year lease, and

WHEREAS, in any event, the tenant, the County of Ulster, shall have the option to terminate the lease for any reason or for no reason, upon sixty days written notice to the landlord, and

WHEREAS, the Public Works and Capital Projects Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Budget and Finance Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute a lease agreement with KEMP Properties for office space for the Department of Health located at 123 Partition Street, Saugerties, New York, for a five-year term commencing May 1, 2010 and ending April 30, 2015, at an annual cost of \$17,325.00, in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney,
