WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to enter into a lease agreement with Blundell Adjustment Company, Inc., for office space of the Ulster County Arson Task Force, 147 Green Street, Kingston, NY, for a term of five (5) years commencing April 1, 2006 through March 31, 2011, at an annual cost of \$4,140.00, in the form as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney, and

FURTHER RESOLVED, the Lessee may terminate this lease for any reason whatsoever upon a 30 day written notice to Lessor, and
