# Resolution No. 69 March 8, 2006

Authorizing The Chairman Of The Ulster County Legislature To Amend A Contractual Agreement From The New York State Office Of Homeland Security – Reallocation Of Grant Funds – Amending 2006 Ulster County Budget – Sheriff's Office

The Criminal Justice and Safety Committee (Chairman Dart and Legislators Distel, Gregorius, R.A. Parete, Zimet, Aiello and Every) offers the following:

WHEREAS, the New York State Office of Homeland Security, has provided a grant in the amount of \$100,000.00 to be used for Law Enforcement Terrorism and Prevention Program (LETPP) whose goal is to prevent and respond to terrorist attacks, minimize the danger and help recover from terrorist attacks, and

WHEREAS, the Ulster County Sheriff has been awarded a grant to provide \$40,000.00 for communications equipment and interoperable technology, \$30,000.00 for mobile data communications equipment and \$30,000.00 for Personal Protective Equipment (PPE), and

WHEREAS, the Ulster County Sheriff is requesting that \$60,000.00 in funds for the mobile data communications equipment and Personal Protective Equipment (PPE) be reallocated to Night Vision Equipment (\$58,600.00) and training expenses (\$1,400.00), and

WHEREAS, the grant requires no matching County dollars, and

WHEREAS, the Criminal Justice and Safety Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an amended agreement from the New York State Office of Homeland Security, in the form as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney, and

FURTHER RESOLVED, that the 2006 Ulster County Budget is hereby amended as follows:
