The Economic Development, Housing, Planning and Transit Committee (Chairman Maloney and Legislators Frey, Hayes, Aiello, Sweeney, Terrizzi, Donaldson, Loughran and Rodriguez) offers the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Ulster County Department of Public Transportation (UCAT), and

WHEREAS, pursuant to Resolution No. 282, August 8, 2007, the Chairman of the Ulster County Legislature was authorized to sign a three year contract with the New York State Department of Transportation (NYS DOT) to accept operating funds for a new public transit bus service between Ulster County and the Poughkeepsie Train Station , and

WHEREAS, this project provided a much needed public transit service connecting Ulster and Dutchess Counties while reducing the number of single occupancy vehicles on roads, offering congestion mitigation and air quality maintenance and providing service to the Metro North Train Station in Poughkeesie for years 2008, 2009, and 2010,

WHEREAS, the Director of Public Transportation has requested operating funds to continue such public transit bus service including fare box and advertising with costs being 100 % reimbursable from Federal, State Funds and local operating fares in the amount of \$560,000.00 for the period beginning January 1, 2011 and ending December 31, 2011, by executing Supplemental Agreement 2 to NYS Comptroller's Contract No. C031714, Project PIN No. 8823.24.124, and described in the Catalogue of Federal Domestic Assistance, Number 20.507, as a Federal Transit Capital and Operating Assistance Formula Grant, and

WHEREAS, the Economic Development and Tourism Committee has met and reviewed said funding with a majority of members voting approval, and

WHEREAS, the Ways & Means Committee has met and reviewed said funding with a majority of members voting approval, now, therefore, be it
