

Authorizing The Chairman Of The Ulster County Legislature To Execute A Contract Amendment To Accept Additional Funding From The New York State Office Of Mental Health For Gateway Community Industries, Inc., (Supported Employment) – Amending The 2009 Ulster County Budget – Department Of Mental Health

The Health Services Committee (Chairman R.S. Parete and Legislators Briggs, Stoeckeler, Terpening, Petit, Roberti and Ronk) offers the following:

WHEREAS, the Ulster County Department of Mental Health contracts with various organizations to provide a variety of services to County residents, and

WHEREAS, the Ulster County Department of Mental Health has received notification from the New York State Office of Mental Health regarding an increase in funding for Gateway Community Industries, Inc., in the category of Supported Employment, and

WHEREAS, in order to accept the additional funding, the contract and the 2009 Ulster County Budget must be amended, and

WHEREAS, no matching County dollars are required for these programs, and

WHEREAS, the Health Services Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval, now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute an amendment and any further amendments to the above referenced contract in order to accept the additional funding in the amount of \$4,432.00 (or less due to New York State budget reductions) from the New York State Office of Mental Health for Gateway Community Industries, Inc., in the form as filed with the Clerk of the Ulster County Legislature or as modified with the approval of the County Attorney, and, be it further
