Requesting Transfer From Contingent Account For Allocation Of Funding To Contract Agencies – Amending The 2006 Ulster County Budget

The Ways and Means Committee (Chairman Lomita and Legislators Bartels, Berardi, Gregorius, Provenzano, Zimet, Cummings, Gerentine and Noonan) offers the following:

WHEREAS, the Ulster County Legislature allocated funds for Contract Agencies in a contingency reserve to be reallocated upon request with sufficient justification, and

WHEREAS, the Ulster County Budget Reform Committee (subcommittee of the Ways and Means Committee) has recommended an allocation of funding for the year 2006 to be awarded to Contract Agencies, and

WHEREAS, the Ulster County Budget Reform Committee has established the following criteria for funding contract agency grant awards:

- 1) Impact on County programs and cost savings to the County Taxpayers provided by each organization, and
- 2) The percentage of each agencies budget that funded by County dollars, and
- 3) How would a 50% reduction allocated in the 2006 adopted budget impact each agency's program: could they exist with a 50% allocation level, or if not, would it be necessary to increase or cut all funding for the program, and
- 4) Were other sources of funding dependent on County funding, and
- 5) A review of all requests, including first time requests were evaluated based on the results of the foregoing criteria.

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of the members voting approval.
