Chairman of the Public Works & Capital Projects Committee, Dean J. Fabiano, and Deputy Chairman John Parete offer the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Public Works; and

WHEREAS, the Ulster County Commissioner of Public Works requests funds for rehabilitation of the Sauer Bridge (Ulster County Bridge No. 70) on Glasco Turnpike, over the Esopus Creek in the Town of Saugerties (BIN# 3346850); and

WHEREAS, the Sauer Bridge superstructure has recently deteriorated to the point where it will soon be unsafe for the traveling public, and it is now necessary to request funds for rehabilitation; and

WHEREAS, the Sauer Bridge is listed on the Transportation Improvement Program (TIP) under PIN #8759.88 with a date to begin the engineering design phase in 2015 and a date to begin construction in 2018; and

WHEREAS, a delay of five years to the commencement of the construction of the project will jeopardize the safety of the travelling public, and therefore the project should be removed from the TIP; and

WHEREAS, the Ulster County Department of Public Works intends to contract with an outside bridge contractor for the design and the rehabilitation of the Sauer Bridge during the current construction season by establishing a Capital Project; and

WHEREAS, based upon examination by the Ulster County Legislature, the County's funding of this Project constitutes a Type II action as defined under Section 4.5.6 of the County of Ulster's State Environmental Quality Review Act (SEQRA) Type II List, which was adopted pursuant to Resolution No. 118 dated April 20, 2010; and
