

Authorizing The Chairman Of The Ulster County Legislature To Execute A Contract With The New York State Department Of Health, Bureau Of Communicable Disease Control For The Aid To Localities Rabies Reimbursement Program – Department of Health

Chairman of the Health and Personnel Committee, Robert T. Aiello, and Deputy Chairman Jeanette Provenzano offer the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of the Department of Health; and

WHEREAS, the Commissioner of Health requests that the Chairman of the Ulster County Legislature be authorized to execute a contract (NYS Contract No. C-027951), and any amendments thereto, with the New York State Department of Health, Bureau of Communicable Disease Control in the amount of \$196,384.40 for the term April 1, 2012 through March 31, 2017; and

WHEREAS, these funds will be used to support the provision of human rabies treatment, specimen collection and shipment, pet vaccination clinics and education and prevention activities; and

WHEREAS, first year (April 1, 2012 through March 31, 2013) funding of \$39,276.88 is now available and is included in the 2013 Ulster County Budget; now, therefore, be it

RESOLVED, that the Chairman of the Ulster County Legislature is hereby authorized to execute a contract, and any amendments thereto, with the New York State Department of Health, Bureau of Communicable Disease Control for the Aid to Localities Rabies Reimbursement Program, in the amount of \$196,384.40 for the term April 1, 2012 through March 31, 2017, in the form as filed with the Clerk of the Legislature or as modified with the approval of the County Attorney,
