WHEREAS, the Office of the State Comptroller has recommended that State agencies begin using contracts written for a five (5) year term rather than a multi-year contract which will expedite internal processing of future annual contractual amendments, and

WHEREAS, the Director of Probation has requested that the Chairman of the Ulster County Legislature be authorized to sign the 2010 Appendix X – Year 5 Contract #C550600 with the New York State Division of Criminal Justice Services-DCJS, formerly known as the New York State Division of Probation and Correctional Alternatives (DPCA) for Ulster County Alternatives to Incarceration Programs for Ulster County's now four (4) Alternatives to Incarceration Programs: Probation Community Service; Probation Pretrial Release, Public Defender's Office Defender Based Advocacy; Public Defender's Office Conflict Defender Based Advocacy, and

WHEREAS, this amendment is for the contract period January 1, 2010 through December 31, 2010 and funding in the amount of \$68,949.00, and
