The Legislative Programs, Education and Community Services Committee (Chairman Harris and Legislators Belfiglio, Hayes, Terrizzo, Donaldson, Gregorius, and Madsen) offers the following:

WHEREAS, this resolution has been submitted by the County Executive on behalf of Ulster County STOP DWI, and

WHEREAS, the Coordinator of Ulster County STOP DWI has requested that the Chairman of the Ulster County Legislature be authorized to execute a contract (NYS Comptroller's No. T523439), and any amendments thereto, with the New York State Division of Criminal Justice Services (DCJS#II10523439) for the period October 1, 2010 through September 30, 2011 in the amount of \$45,634.00, and

WHEREAS, these funds will be used for the Governor's Traffic Safety Committee (GTSC) Ignition Interlock Device Monitoring Program (the "Program") to allow Ulster County STOP DWI in collaboration with Ulster County Probation to increase available monitoring services to a level which is in accordance with the number of individuals being monitored pursuant to the Program, which shall promote and increase community safety, and

WHEREAS, the Legislative Programs, Education and Community Services Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, the Ways and Means Committee has met and reviewed said request with a majority of members voting approval, now, therefore, be it

RESOLVED, that the 2011 Ulster County Budget is hereby amended as follows:
