Direct Connect is a strategy to mobilize our entire county to address linking youth and families to the broad spectrum of services available in Ulster. It employs an online resource directory which can be expanded to include the full array of services in our county as well as a web-based screening tool to catch youth vulnerable to substance use and abuse and link them to the right supports for their level of need. The initiative includes a mapping feature that shows resources by location to make finding accessible services easy and convenient. Direct Connect was developed in Ulster County and is now gaining state and national attention.

UlsterCorps is a county-wide volunteer resource organization working with individual agencies to encourage volunteer use, facilitate successful volunteer placements, and nurture collaborations among agencies.
