Commissioner's Report: Director of Finance Hinchey presented fiscal and Safety Net

Youth Bureau Report: Director of the Youth Bureau Barringer presented. She extended an

invitation to legislators to attend the 8th Annual Youth Recognition

Awards on May 29, 2008 at The Bruderhof, in Rifton.

IKON Contractual/Fiscal Cost Update: Finance Director Hinchey submitted a report on cost

savings involved regarding leasing of copiers. A three year comparison of costs was presented with a handout, regarding leased vs. owned copiers, including maintenance costs and technology capabilities. A discussion followed regarding the State pilot imaging project and how to possibly

incorporate the use of new equipment in the future.

Day Care Statistics Update: Commissioner Rodriguez presented day care statistics that had been

compiled by Director of Resource Recovery Warman with various categorical comparisons, under the NYS Child Care Block Grant and under Title XX funding. Statistics included the

population served, case and current provider types.

ACCESS Program Update: Director of Temporary Assistance Knudsen updated the Committee on proposed changes to the ACCESS Program, administered by SUNY Ulster. Under consideration is to offer short term certificates of completion for various program areas to assist with retaining students enrolled and to provide employable skills in shorter intervals. It was suggested that 3-6-9 month certificates of completion be offered to students that have difficulty with attendance as well as to provide an incentive regarding their commitment to further their education. For more committed students the completed certificates will be transferable and students will be able to continue their education toward an Associate Degree. This agreement between Social Services and SUNY Ulster will be finalized in May by Commissioner Rodriguez and President Dr. Katt.

Temporary Assistance Intake Applicants: Director of Temporary Assistance Knudsen presented statistics of new applicants within the last three weeks of February, Legislator Loughran motioned to supply funds for a study to be completed to show the projected costs, for the next five years to service this population. Motion was not seconded and no further discussion took place. Legislator Loughran motioned to request the cost of a project to actually conduct this study, Legislator Terrizi responded that when a cost is established she will then consider supporting such motion. No further discussion took place.

Staff Development: Legislator Noonan inquired about the vacancy of the position of Director of Staff Development. Commissioner Rodriguez stated that one candidate in-house and one outside the Agency have been interviewed by the Directors and Coordinators, and he will be interviewing them.

Being no further business, motion offered by Legislator Noonan, seconded by Legislator Terrizi, and adopted to adjourn the meeting at 6:35 p.m.
