Chairman Bischoff called the meeting to order at 6:10pm. The meeting was held at the Board of Elections offices on Wall Street.

Legislator Shapiro brought to the committee's attention the NYS Kennel Club's intention to seek change in the state's laws regarding discrepancies in classifying guide dogs verses therapy dogs. He advised the committee that he had yet to speak to local state legislators and will have his recommendations for a memorializing resolution at the next meeting.

Commissioner Turco and Board of Elections Administrative Assistant Jay Mahler gave a demonstration of the new Sequoia ImageCast Ballot Marking Device voting system. Commissioner Turco and Deputy Commissioner Mihm spoke about the additional staff brought in to assist with the large amount of registration forms being received. The committee had a lengthy discussion on the procedure for charging back election costs to the towns and the future fiscal implications of the Help America Vote Act and the new voting systems. The Board of Elections provided committee members with a copy of the 2009 estimates for town election costs, based on County Resolution 401 passed in 2006. The estimates were mailed to Town Supervisors/City Mayor and Town/City Clerks on October 6, 2008.

Chairman Bischoff moved on to the Administrative Code and that he would like to amend \S A2-5 B to read "No current for former County Legislator may be appointed \underline{or} $\underline{confirmed}$ by the Ulster County Legislature"

MOTION by Legislator Rodriguez, 2nd by Legislator Decker: to amend § A2-5 B of the Ulster County New York Administrative Code to read "No current for former County Legislator may be appointed <u>or confirmed</u> by the Ulster County Legislature"
