Following the Public Hearing on the 2010-11 budget of Ulster County Community College, and a quorum for each committee being present, Deputy Chairman Donaldson and Chairman Gerentine called the joint meeting to order at 6:40pm and presented to their respective committees the following proposed draft Resolution #153:

“The Legislative Programs, Education and Community Services Committee, (Chairman Wayne Harris, Deputy Chairman Donaldson and Legislators Belfiglio, Hayes, Terizzi, Gregorius and Madsen) and the Budget and Finance Committee (Chairman Gerentine, Deputy Chairman Lomita and Legislators Gernardo, Frey, Gregorius, Hansut, Harris, Maio, Maloney, Provenzano and Sheeley) offer the following:

WHEREAS, the Board of Trustees of the Ulster County Community College has requested approval of the proposed budget for the fiscal year beginning September 1, 2010 and ending August 31, 2011, pursuant to the laws and rules applicable thereto, and

WHEREAS, the Legislative Programs, Education and Community Services Committee has met and reviewed said request with a majority of the members voting approval, and

WHEREAS, THE Budget and Finance Committee has met and reviewed said request with a majority of the members voting approval.

RESOLVED, that the Ulster County Legislature does hereby approve said Budget, as filed with the Clerk of the Legislature, in the amount of \$28,583,614.00 providing for a contribution by the County through a tax levy for the year 2010 in the amount of \$6,280,863.00,a

And moves its adoption.

Gregorius for both committees, the joint meeting duly adjourned at 6:48pm.
