"Faced with difficult economic conditions, rapidly changing technologies, global competition and the need to retain and grow highly skilled, high wage jobs in New York State, Hudson Valley manufacturers, in conjunction with the Mid-Hudson Regional Council, have identified the establishment of a Center for Global Advancement Manufacturing (CGAM) as a regional strategic initiative. Formation of the Center will improve and expand services in support of manufacturing in the Hudson Valley. The Center will assist companies to improve product innovation operational productivity, supply chain management and regional partnerships, thereby strengthening global competitiveness. Finally, and most importantly, the Center will link manufacturers with educational institutions and workforce development agencies to train and hire the skilled workforce necessary to sustain and grow manufacturing here in the Hudson Valley. To begin this work, \$50K

in NYS assistance is requested to help legally form this non-for-profit center with the State University of New York (SUNY).

To support this valued manufacturing sector, a uniquely qualified team of established local resources, enhanced by the specialized capabilities of the State University of New York, proposes to create the Center for Global Advanced Manufacturing in the Hudson Valley. The SUNY Institute of Technology (SUNYIT), The Solar Energy Consortium (TSEC), Council for Industry (CI), Hudson Valley Technology Development Center (HVTDC), Mount St. Mary College and the region's community colleges ("Founding Organizations") are in the process of legally forming a 501(c)3 not-for-profit center.

Simultaneously, the Center is working to setup by end of 2012 a Characterization & Test Lab at Gateway Industries in New Paltz with \$1M in capital equipment funding secured by TSEC. The shared equipment and facility will be made readily available to manufacturers and educational institutions for research, product development and failure analysis, pre-certification testing and training."

<u>Chairman's Update</u>: Re-evaluation of Economic Development Structure
 Chairman Maloney said the Chairman of the IDA and the Chairman of the UCDC have met to determine a
 more seamless operation between the two agencies. Chairman Maloney has met with them as well and
 they are looking at all of the relationships throughout New York State regarding private/public partnership
 and discussions are ongoing and evaluations are being made.

Amanda LaValle provided an overview.

- Amanda's office is involved in all aspects of the projects.
- This Resolution already passed through the Law Enforcement & Public Safety Committee.
- All properties abatements for asbestos will be evaluated before closings take place.
- Only current resident homeowners qualify for the flood remediation program all voluntary.
- Previous owners of homes sold or left their property do not qualify.
- The County of Ulster will hold the titles.
- Parcels grouped together could possibly be utilized as a community park if the community chooses recreational use / open space which is included in the deed.
- Two other resolutions posted on the internet, (funding approval) #61 & #62 in conjunction with this are going before the Law Enforcement & Public Safety Committee.
- DEP portion is \$3.7 million and the State portion is \$3.8 million not nearly enough.
- The Dept of the Environment normally is classified as the lead agency for "coordinated reviews" however, the SEQRA review is considered an "uncoordinated review" technically there isn't a designated lead agency, thus the County is acting as the lead agency.
- The programmatic evaluation of eligible homes will vary/evolve up until the time of the closings. SEQRA is setup whereas as much information up front as possible is required to evaluate funding, etc.
- The County is following the same procedures used for the first round of the buyout on the lower Esopus 2-3 yrs. ago.
- The end result is being viewed as an environmental benefit thus treating each demolition accordingly.

Approx. 60-65 homes are involved.

Q -Legislator Wishnick asked if any calculations have been made as to the impact on property taxes and any compensation being offered to the county.

A -Amanda LaValle is not aware of any - under a more programmatic review possibly the county may see compensation. JJ Hanson noted the county evaluates only the county tax levy impact portion which he feels will be negligible. Revenue loss within the town would be spread over the Town of Wawarsing - not the County. JJ offered to have a ball park estimate at the next Ways and Means Committee.

Legislator Lopez wants the best possible outcome for his constituents.

Legislator Bartels had numerous inquiries answered above.

Legislator Ronk noted homeowners who take advantage of this buyout must waive their rights to file lawsuits against NYC however homeowners opting for the State plan still have the right to file a lawsuit, as discussed in the Law Enforcement & Public Safety Committee.

Administrative Code Adding Chapter 306 "Hydraulic Fracturing Brine Prohibition

Act"), To Be Held On Tuesday _____, 2012 AT ____PM.

A motion was made by Legislator Ken Wishnick to refer this proposed Local Law 1 of 2012, entitled Hydraulic Fracturing Brine Prohibition Act to the Law and

Rules, Governmental Services Committee pursuant to Rule 7(E)(1)(a) of the Rules of the Ulster County Legislature.

Discussion: Legislator Wishnick described the hydraulic fracturing process which produces a byproduct called saline/brine – not to be mistaken for other types of "brine". The hydraulic fracturing byproduct/wastewater is laden with potentially hazardous chemicals. Disposal of this free material is currently being offered in western parts of NYS around the Ithaca area for deicing roadways, dust control, and other purposes. The DEC monitors the soil around the road area once a year. Ulster County does not currently use this byproduct. Introductory Local Law 1 of 2012 clearly spells out prohibiting the use of Hydraulic Fracturing Brine on Ulster County controlled roads. Committee discussion ensued.

Chairman Belfiglio noted the date to set the public hearing will be addressed upon passage in the Laws and Rules Committee meeting. Last year the Legislature passed a resolution banning hydrofracking on county lands without knowing much more than we know today.

Legislator Parete again stated more information is needed about the DEC/DEP standards currently established for roadways. He would like to hear more from the experts. Leg. Parete researched the Ithaca area usage, whereas vertical deep well, sandstone foundation drilling waste is used for deicing of roadways - not the same byproduct.

Legislator Ronk concurred with Legislator Parete's thoughts as to lack of standards available. Legislator Ronk will support this motion to allow for public input. Not sure of his stance at this time.

Legislator Bartels is comfortable not knowing the chemical composition/makeup of the brine to pass this legislation.

Legislator Lopez wanted to be sure not to write into legislation "all brines", as he has a small business constituent that has been producing brine from salt mines for 20yrs. His constituent felt this is a rush to judgment – jury is still out. Legislation could possibly affect his constituent's livelihood.

The county executive office had no comment on this topic, respectfully, until after proper review is taken.

Public Comment on Resolution #71, "Hydraulic Fracturing Brine Prohibition Act:

Mr. Peter Robbins, Marbletown DCC: What will happen if this doesn't go to the Laws and Rules Committee? Chairman Belfiglio confirmed it will go to the committee. Legislator Ronk added, if it doesn't pass Laws and Rules it will come up again next month. Mr. Robbins also wanted to say a copy of this draft is going before the Marbletown DCC tonight and will most likely support it. Also, the hydrofracking being discussed is horizontal fracking which is more harmful to the environment. In today's corporate climate, Mr. Peters finds it appalling that the industry would expose the public to potential harm.

<u>Patricia Anderson, Marbletown Citizen</u>: Strongly supports this resolution. The public doesn't know the makeup of the brine as companies claim its proprietary information.

Chairman Belfiglio noted the public will be able to express their thoughts once the Public Hearings are scheduled.

New/Old Business:

UC Soil and Water Conservation District, Gary Capella, Executive Director:

- Gary has been with Ulster County for 19 years, resides in Wallkill
- Department in existence since 1965 a full service agency
- Soil & Water is located Rte. 299 Time Square Professional Office Bldg, Highland, (just outside the Village of New Paltz) – Also have a Satellite office in Phoenicia
- Website www.ucswcd.org
- Governed by a local Board of Directors appointed by the Legislature
- Board has representatives from the Legislature, Farm Bureau, Grange and At-Large.
- Funded primarily by county appropriations and partly by NYS reimbursement
- Supplemental income is generated through annual tree and shrub sale, fish pond stock program, sale of wildlife nesting boxes, computer generated and topography maps.
- Fees are charged for pond site feasibility investigations & the completion of Soil Group Worksheets for agricultural tax exemptions

NYS Agricultural and Community Relief Fund – ACRF for municipalities in the aftermath of Hurricane Irene & Tropical Storm Lee:

- Total funding was \$5 million appropriated for 30 counties in NYS
- UCSWCD applied for & awarded \$334K to be used towards 28 farms in Ulster County located in the Irene/Lee disaster declaration zone final costs and photos of completed farms attached
- Emergency Services were provided for the Ag District over the past seven months goal was to have farms recover as soon as possible from Irene and Lee.
- Corrected debris laden fields, laneways, drainage systems, fencing & stream crossings, breached irrigation ponds
- Farmers provided approx. 10% of the cost sharing. The other 90% was program monies, whereas some worked out to be the exact cost of the program funding allocation.

<u>USDA Emergency Watershed Protection Program (EWP) – Watershed Impairment Relief for municipalities in the aftermath of Hurricane Irene & Tropical Storm Lee:</u>

- EWP provides up to 75% of repair costs, local sponsor 25%, cash and/or in kind service
- Assistance was requested by 15 municipalities to date unprecedented # of requests
- Sites will be evaluated through March 31, 2012
- Total value of the damage survey report estimates are \$4 million
- 17 sites qualified photos attached

*Gary provided the committee with various literatures, newsletters, 2012 Tree & Shrub Conservation Planting Order Form, USDA Emergency Watershed Protection Program (EWP) Watershed Impairment Relief for UC Municipalities in the aftermath of Hurricane Irene & Tropical Storm Lee. (Literature provided on file with the Legislative Clerk along with the mtg. minutes)

- Q Chairman Belfiglio asked Gary about the Esopus turbidity levels. What effect is it having on people living along the Esopus?
- A A lot of debris, killed corn farms, quality of water, some erosion mostly field damage.
 What is the difference before and after these releases? A Receiving a lot more calls for erosion, field damage, irrigation systems.

Legislator Wishnick provided an overview/update to the committee, with the goal moving forward to bring the RRA to the point of revenue neutral. Some of the issues the RRA is facing: (See last months minutes for additional info)

- County property taxes directly subsidize operating losses known as "Net Service Fee" on a yearly basis.
- Net Service Fee ranges from \$1.2 to \$1.5 million annually including payment of principle & interest on the outstanding bonds.
- Bonds include costs for failed efforts in sighting a county landfill, closure costs for three municipal landfills and the cost of establishing municipal recycling centers
- Current payoff for bonds is approx. \$20 million in principal + \$3 million in prepayment costs totaling \$23,772,504.50 verses on the current schedule would be around \$30 million.
- 150,000 tons of waste per year taken in. RRA permits allow up to 324,480 tons per year.
- Approx. 900,000 gallons of diesel fuel expended annually to transfer waste to Syracuse/Rochester area
- Lack of locating a land fill in our area has put ourselves in this position of debt
- Seneca Meadows contract expires 2014 deliver 100K tons/yr contract whether we bring the waste or not
- High Acres contract states 4500 tons (1/3rd of all waste going through the RRA) of waste brought to the RRA by Waste Management must be sent to the High Acres landfill which Waste Management owns. The contract expires this year. The tipping fee is substantially reduced to keep their business. Waste Management can utilize its own transfer station at any given time. Waste Mgmt. just renewed a permit for a transfer station right down the road from the RRA. The RRA is breaking even covering their costs under this contract.
- Other "buy in" discounts given to others. The more waste lost the higher the net service fee.
- Almost all municipalities contracts expire this year RRA at risk of substantial loss of revenue
- Taylor Bio Mass in Orange County not sure this system can be fully successful
- Increases in recycling will, by intent, reduce incoming waste
- Ulster County's growth & development has been lagging less new waste sources
- New Paltz received a grant to achieve zero waste or as close to it as possible program upcoming at New Paltz College
- The more the RRA promotes recycling the more net service fees needed it's a conflict of interest for the RRA. Needs restructuring.
- With potential loss of volume in both trash and recyclables, it is conceivable property tax subsidies may
 double or triple in the next few years
- Ulster County is not growing not producing more waste
- At the Materials Recovery Facility, substantial investments were made to process materials that are source separated. The incoming volume is declining due to increasing single stream (commingled) recyclables and this volume is now going elsewhere.
- Tim Rose and Legislator Wishnick is working on gathering resources available to make the RRA self sustaining, such as "pay per throw" charge people creating the trash think of trash like you do water usage.
- Bonds created were to help towns close their own landfill and create a transfer station need to remind town boards

Legislator Parete noted the UC Legislature had the RRA roll over the RRA bonds/debt to 2028 to lessen the tax burden. The bonds should have been paid off in 2014-2015.

Legislator Bartels asked if the Taylor Bio Mass System can be viewed in operation anywhere. No not at this time.

Legislator Bartels strongly felt siting a landfill in Ulster County should be part of this committee discussions/solution.

Chairman Belfiglio has researched landfill sitings - very expensive and not popular with the public.

Chairman Belfiglio thanked Legislator Wishnich for all the work and research he is doing with the RRA.

The RRA Board is having a meeting on March 19th 3:30 PM and all Legislators and public are welcome to attend and ask questions.

Lyme Disease Awareness in the Hudson Valley, Doreen Peone, Saugerties:

Chairman Aiello invited Doreen Peon, an advocate and sufferer of Lyme disease since 2008 to come before the committee to share her personal experience and dedication, making others aware of how easily this disease can be misdiagnosed, with devastating consequences. Questions:

Legislator Belfiglio: If we accept this money, is the City going to say, "okay, that's it, we wash our hands of the issue in Wawarsing," or can we go back to them for more money? Should we hold out for more?

Answer- Counsel Langdon Chapman: Counsel understands that the City is making individual residents who choose to take advantage of this sign some sort of release. There are several lawsuits filed and the people who choose to take the money are going to have to discontinue their lawsuits. The people who want to continue on with suing the City of New York may keep on doing so.

Answer- Leg. Chairman Bernardo: The \$7 million allocated and offered is not enough to reasonably satisfy all of the affected residents. The Chairman plans to go back to Albany to ask for more and go back to the DEP to get matching funds.

Question- Legislator Belfiglio: In reference to the tax revenue lost on these properties, once the residents, who were the victims, get satisfaction, the County then becomes the victim. What can be done about that?

Answer- Leg. Chairman Bernardo: It is the hope of the Chairman that after the hearings conducted by the Environment, Energy and Technology Committee begin, and the groundwork is laid to subpoena the DEP and DEC, things may be discovered in that questioning which may result in reimbursement to the County for things it has struggled through.

Art Snyder, Emergency Management, provided the following information:

There are 68 families that expressed an interest in the Wawarsing buyout.

There are 7 families that are not eligible for either program.

The remainders are eligible for one, or the other, or both the state and city programs. The next step will be to determine of those eligible for the city program, who is willing to accept the terms of the city program.

Additional "bonus points" are applied to those eligible (and willing to accept) the city program.

Only then will we be able to compile a list.

Appraisals will not be conducted until after the list is finalized (to be fiscally prudent).

Question- Legislator Ronk: Will this work like the first round of buyouts where the County takes title of the property and maintains the property until the County finds some open space purpose for it?

Answer- Art Snyder: Correct. The County will retain ownership. The deed will be modified that the property will only be used for recreation, for flood control, for wetlands use. The property can be sold. The problem to be aware of is that there could conceivably be one person left in the middle of this entire area. • OLD BUSINESS:

- 1) Undersheriff Frank Faluotico addressed the issue raised by Tom Kadgen at last month's meeting regarding Dutchess County having fewer parole violators in their jail compared to Ulster County. The Undersheriff said the average time in NYS that an inmate sits in a County jail before going back into the State system is 47 days. Ulster County is one day off the State average, at 48 days. Information from last month said Dutchess County was within 19 days. The Undersheriff said according to Parole it is impossible to move them that quickly. The difference between Dutchess and Ulster Counties is that when Ulster County books a parole violator into the jail, he is logged in as a parole violator. Dutchess County books the individual in on the original arrest charge, and then when he is cleared on the original charge, they then document him as a parole violator.

 Tom Kadgen distributed an article to the Committee titled, "The County Burden of State-Ready Parole Violators" which remains on file in the Office of the Clerk of the Legislature.
- 2) ILL No. 3 of 2011 (A Local Law Of The County of Ulster, New York Protecting Animals From Abuse By Establishing A Registry For Animal Abusers)- The Sheriff and Undersheriff expressed support for this Local Law, but suggest all fees resulting from the Local Law be paid to the Sheriff's Office. The Sheriff will meet with Legislative Chairman Bernardo within the week to discuss details of the final amendments to the Local Law.

• NEW BUSINESS:

Undersheriff Frank Faluotico spoke to the Committee about a shortage of funds to purchase 5 vehicles. These vehicles were removed from the budget by the Executive. At that time, the funding to equip the vehicles was also removed from the budget. This equipment was funded through the IS budget. The Sheriff went to the Legislature to get the vehicles put back into the budget, but at that time did not

request to have the equipment funding restored as well. The original amount budgeted for the equipment was \$73K. An inventory of spare equipment and equipment being removed from cars coming off-line revealed the ability to change the \$73K to \$44,985. The only solution the Sheriff's Department sees is taking the funds from contingency.

In addition, the estimated budget for purchase of the five vehicles was short \$5K per car. An additional \$25K is needed to purchase the vehicles. The Undersheriff understands that the County is committed to all five cars. The Sheriff will see if the \$25K can be found elsewhere in his budget, but worse case scenario their suggestion would be to bond for the additional \$25K.

The Sheriff's immediate request is for this Committee to pass a resolution for \$44,985 to be taken from contingency for purchase of equipment for the vehicles.

The New York State Housing Trust Funds are expected to be made available from the 2008-2009 Greater Catskills Flood Remediation Program, and may be used for the purchase and remediation of flood and water infiltrated residential properties affected by the New York City aqueducts in Ulster County. Determination of eligibility for this New York City DEP Program is subject to certain criteria that will impact eligibility for the New York State Housing Trust Fund Program, and therefore it may be necessary to transfer funding between this Capital Project, No. 355, and Capital Project No. 356. The goal of this program is to remove people and their possessions from harm's way in areas that have been hit particularly hard by flooding and enable homeowners with properties that meet certain criteria, to relocate from areas that remain vulnerable to flooding or water infiltration. This program will be managed by Ulster County Emergency

Communications/Emergency Management, and the County would be authorized to purchase properties and demolish structures and such properties will be dedicated in perpetuity for open space, recreational, wetlands or flood mitigation purposes.

Additional Questions and/or Comments: The Committee further discussed the criterion that determines eligibility. Legislator Briggs stated that at last nights Law Enforcement & Public Safety Committee, they had concerns that if a resident participates in this program that they could essentially lose their right to file a suit. He also stated that once these homes are purchased, they become forever wild and this creates a tax revenue loss. Bob Sudlow explained that the residents of Wawarsing will have to choose which option they want to take, the DEP or the DEC and what that entails. Ronga: Stated that there were questions/concerns with regard to Ulster Heights Road and how it was determined a Federal Secondary Highway, therefore ineligible for FEMA but eligible for FHWA. She spoke with Dennis Doyle (Director, UC Planning Department) and asked how that determination is made and what that determination means to Ulster Heights Road, and what are the advantages and disadvantages to that determination. Those answers were put in writing and handed out to the Committee (See Attached). Sue also stated that representatives from the Public Works Department will be attending the Wawarsing Town Board Meeting on April 5th @ 7:00 PM with regard to the Ulster Heights Road issues/concerns.

Briggs: Will also be attending that meeting. He said the people of Ulster Heights are up in arms and they have huge concerns with regard to the delay in Fire and EMS rescue, and their response times.

Briggs: Q/When was this determination made; he stated that this is what his constituents are asking, they are asking for clarification. A/Ronga clarified that it was submitted through FEMA first. She explained that it takes years when it is on the TIP, and clarified that these repairs are not on the TIP. This will be treated as an emergency repair. Sudlow: Asked the Committee to be a positive voice to say "Engineering" is not just a slide rule of someone drawing a picture, that it is a very extensive process of looking at the damage and putting those plans together and planning for right-of-ways, he said a whole multiple of things need to be completed going forward.

They look at the CHIPS funding and the approved Capital Projects, and the Budget and they decide based on the dollar amount and what they know needs to be done in priority order, it is determined what can be done and what can wait. This is a three week process that is done every year.

(The County's share for Medicaid services is 25% up to the set cap of expenditures and when the County reaches the threshold then State & Federal Governments cover expenses 50/50.)

The Committee & Erica discussed their role with regard to the review of Contracts and their subsequent vote of the Abstract at Session.
