***PRIVILEGE OF THE FLOOR:**

Chairman Terry L. Bernardo granted Privilege of the Floor to Butch Dener. Mr. Dener, an organ donor recipient himself, will present information regarding Organ Donor Month and sharing the joys of family. He will be joined by living donor recipient Geraldine Buck, and full donor recipient Charles Lyonhart, who will speak about their personal experiences helping to change lives.

Chairman Terry L. Bernardo called upon Legislator Jeanette Provenzano, Deputy Chairman of the Health and Personnel Committee, to present a Proclamation to Butch Dener, on behalf of the Ulster County Legislature, declaring the month of April Organ Donor Month. Legislator Provenzano invited the other members of the Health and Personnel Committee: Legislators Belfiglio, Ronk, and Robert Parete to join her in presenting the Proclamation. Legislator Robert Aiello, Chairman of the Health and Personnel Committee was not present.

CALL OF THE PUBLIC HEARING BY CLERK: Proposed Local Law No. 1 Of 2012 (A Local Law Known As The “Hydraulic Fracturing Brine Prohibition Act”)

PUBLIC COMMENT: There were 61 speakers at tonight’s public hearing.

- 1. Amanda Lavallo – Coordinator of the Ulster County Dept. of Environment .** Ms. LaValle shared statement on behalf of the County Executive. Stated a major issue of continuing concern not only of the County Executive’s Administration but of the people of Ulster County. Not only the issue of hydrofracking. Second issue causing apprehension of many concerned about the environment, was the potential use of brine on County roads. On April 12, the County Executive signed Executive Order Executive #1 of 2012, banning potential use of all hydrofracking byproducts on any and all county roads. Because of time constraints in passing of a local law, the Co. Exec took action to immediately alleviate public concern. County Executive applauds Ulster County Legislature for their efforts and looks forward to signing local law and encourages municipalities within the County to do the same.

2. **Scott Carlsen – Supervisor of the Town of Wawarsing.** Thanked Legislature for holding meeting in venue where all could attend, great example of local government. Commended Legislature as a whole for taking time to look at the Law and get it right. Pointed out that Craig Lopez called Mr. Carlsen with concern of local company in Ellenville that uses a brine product on road invented long before the hydrofracking brine. The company employs many and is used nationwide. Fear was that law was too general and could have negative impact on this local company. Mr. Carlsen put the owner of the company in touch with Leg. Lopez. On a personal note, he hoped that the Legislature does the right thing, dangerous chemicals are not wanted on the roads.
3. **Susan Zimet – Town of New Paltz Supervisor** – Indicated that Legislature had passed a ban on hydrofracking on County property. Indicated that Leg. Maloney had asked a year ago why the ban only applied to County property. She indicated that it was only the first step. She had recently attended Supervisors meeting in which every supervisor spoke about coming together to adopt a bill to ban fracking in every town within Ulster County. Hoping that Ulster may be first county to have every Town to do a ban bill. Spoke about the Utica shale which is under the Marcellus shale and is within Ulster County. Companies were going to doors in Rochester trying to obtain lease signatures. Generating letter that will be generated and sent to Gov. Cuomo.
4. **Carol “Kerry” Cubas** – Landowner in Bearsville, NY. – Read statement specifying effects of hydrofracking.
5. **Nancy Baysinger**- Spoke in support of banning purchase of fracking fluids on roads, ban use of free fracking fluid or paying companies to take the toxic fracking waste for use. Ms. Baysinger reviewed number of toxic components of fracking fluid and effects on the human body.
6. **Barbara Moley Rusko** – Thank Legislature of hearing and Leg. Ken Wishnick for introduction of the law that may have impact. Had worked earnestly to bring tourism to Ulster County. Believed future of Ulster County is tourism due to the profound beauty of the County. As property owner and business owner, desires safe environment.
7. **Jay Wenk** – written comment on file with Clerk of the Legislature (see copy attached).
8. **Steven Gentile** – Currently lives in Woodstock with his family. Displayed 3 bottles of water to make his point. Indicated that he had replaced water before Legislatures, one of which containing fracking fluid and specified all fluids would appear harmless. Asked that law banning use of brine be passed.

9. **Tom Caplan** - Displayed photo of boy being consumed in dust clout of DDT to support ban on use of brine and hopefully discourage fracking in Ulster County.
10. **Toni Weidenbacher** – Read statement in support of ban against use of hydrofracking ban and the need for clean water. Written comment on file with Clerk of Legislature (see copy attached).
11. **Joan Walker** – Commended Legs. Rodriguez, Gregorius and Wishnick for co-sponsoring law. Called for FOIL for documents of Ulster County.
12. **Andi Weiss Bartczak** - Environmental toxicologist from Gardiner. Spoke of negative effect of use of brine and toxic chemicals contained in same.
