## **PRESENTATIONS:**

Chairman Terry L. Bernardo called upon District No. 9 Legislator, and Chairman of the Legislative Programs, Education and Community Services Committee, Wayne Harris, to present a Proclamation in recognition of November being National Family Caregivers Month to Evelyn Flynn.

Evelyn Flynn, from the Ulster County Office for the Aging and the Ulster Family Caregiver Support Group accepted the Proclamation presented by Leg. Harris and acknowledged Suzanne Van Wagenen as a dedicated contributor to family caregiving. Ms. Flynn distributed a brochure "*Caring Connections of Ulster County*" on file with the Clerk of the Legislature. The brochure also included an invitation to the Annual Family Caregivers Conference at the Kingston Holiday Inn on Friday, April 26, 2013, 8:30 a.m. – 3:30 p.m.

Ms. Flynn noted that the program was non-for-profit and consisted of all volunteers. She stated that there was a very limited budget and support was appreciated. She stated that any help from the media would be useful. Chairman Bernardo noted that the Daily Freeman was present and could be instrumental in that end.

Leg. Gerentine recounted his experiences in working with Evelyn Flynn over the years attested to the hard work and care that Ms. Flynn put into her caregiving services. Leg. Gerentine extended his congratulations to Ms. Flynn.

## **PUBLIC COMMENT:** There were 5 public commentators

- 1) Paul Fowler Addressed the Legislature with regard to the staffing of Ulster County Sheriff's Deputies to oversee the internet sexual predator issue.
- Steve Changaris Environmental Industry Association, Manager Introduced himself and explained his position with the waste management industry. Mr. Changaris has been working with a coalition to identify perils and pitfalls of flow control. He believed, in his community, that the County can sustain the RRA's debt and can manage trash in the County and promote recycling without use of flow control. The basis of his argument was that, with sound waste policies, all things could be accomplished. He stated problem was that it was "debt centric." Mr. Changaris believed that choice in competition would better serve the citizens than a monopoly in flow control Ended by stating that continuation of net service fee helps "level the playing field."
- 3) Howard Baul CSEA Remarked on allowance in Sheriff's budget for bunks in jail and stated that need was created by increase in population. Reflected that the community

Corrections Program was cut and since that cut, the populations appears to coincidently grown. Pinpointed the Children's Unit and questioned the lack of services, how much more will the jail population be affected. Mr. Baul asked that this be carefully scrutinized during the budget process.

- 4) Dare Thompson LWV President Voiced support of the audio recording of Committee meetings. Ms. Thompson stated how advantageous it would be to individuals unable to attend for various reasons. Ms. Thompson spoke in favor of the efforts made by all in the solid waste debate. She stated that the solution the Legislature was leaning toward pleased the LWV; in the emphasis being placed on individuals generating the waste paying for the disposal and the increased competition without the taxpayers subsidizing.
- 5) Cindy Lanzetta LWV Chairperson, Solid Waste Committee Ms. Lanzetta concurred with statements made by Ms. Thompson. Ms. Lanzetta made reference to proposed Resolutions 278 and 279 involved issues that were still important to the LWV. Acknowledged immediate needs of the RRA and urged recognition of larger issues.

Chairman Bernardo thanked speakers and wish to note that there was a plan to amend the date of the Public Hearing to November 27 from December 4.

Chairman Bernardo continued that the following Resolutions were postponed for various reasons – Resolution Nos. 275, 278, 279, 284, 285, 289 & 291.

**Legislator Provenzano** questions the postponement of the Resolutions. **Chairman Bernardo** responded that the Committees had been questioned. **Legislator Provenzano** asked if the sponsors of the Resolutions had been consulted. Legislator Gerentine spoke on behalf of the Ways and Means Committee affirming that Resolutions before that Committee were postponed with the consent of the sponsors (the two Resolutions submitted by Sheriff's Department). Chairman Bernardo requested comment by Legislative Counsel. Council Chapman cited 7(i) "All committees appointed by the Chairman shall act promptly on all matters referred to them. All resolutions and local laws referred to a committee must be acted upon within ninety (90) days or shall automatically be discharged on the 91<sup>st</sup> day and placed upon the written agenda of the next meeting of the Legislature so that the resolution or local law can be considered by the full Legislature...." Legislator Provenzano inquired as to whether the Minority Council agreed with the interpretation to which Council Ruggeri responded that he agreed to the extent that the rule sets forth exactly what the Majority Council had stated but noted it had been the practice and custom, to not allow a Resolution to be withdrawn or postponed unless each of the sponsors wanted to take that action. Council Ruggeri indicated that they were bound by the Rules and he had to concur with Council Chapman. Legislator Ronk stated that it was his understanding was the Committee Chair and Deputy Chair were the sponsors of a Resolution until it passed a Committee, therefore the entire Committee didn't consent until it was passed. Council Chapman responded that the Committee doesn't have to concur. Legislator Bartels stated that on Resolutions 278 and 279, she was Deputy

Chairman on that Committee (to which she was Chair) and it was agreed to postpone those Resolutions with the assent of the sponsors. Chairman asked if any sponsors had objections to the postponement to which there was no response. The Chairman again read the list of Resolutions being postponed. **Legislator Donaldson** recognized who spoke to the face of the submission of the Resolutions, their submissions by the Executive and the exception of the Resolutions generated in Committee and tabled in Committee. **Legislator Donaldson** found no objection to the postponement of the pending Resolutions which were mainly related to amendments to the budget.
