Chairman Gerentine spoke about a letter he had received from a Mr. Feinberg from the town of Wawarsing who claims to be unable to pay his taxes, even with a two-year payment plan. Commissioner of Finance Hewitt stated that Real Property law provides for a two year maximum. Counsel Gilligan will get all the information from Legislator Bernardo and provide an opinion. The County takes over delinquent properties on February 18.
