#### l) **RESOLUTIONS**

Resolution No. 168 Authorizing The County Treasurer To Accept And Reject Bids For Purchase And Refund On Parcels Of County Owned Property At The April 17, 2008 Public Auction

Motion offered by Legislator Cahill, seconded by Legislator Dart.

Adopted unanimously.

Resolution No. 169 Authorizing The Conveyance Of County Owned Property To Original Owner

Motion offered by Legislator Dart, seconded by Legislator Cahill.

Resolution No. 170 Authorizing The Ulster County Treasurer To Assign It's Rights On A Parcel Of Property Previously Offered At Public Auction

Deputy Treasurer Adele Reiter explained that this parcel was a former gas station and it is County policy to <u>NOT</u> take title and ask Judge to convey the property directly to interested party-in this case the Village of Saugerties.

Legislator Provenzano - Had a problem with a 30 year veteran of a

department losing longevity according to the terms of the new proposed CSEA contract.

Legislator Cahill – Supports CSEA 100% and since they feel it was a fair contract we should approve it in its present form and not amend it.

Legislator Gerentine – We should not circumvent the union negotiations.

Legislator Provenzano – It is not fair to punish a small group of 30 year veterans whether they are managers or rank and file. Is longevity included in the figures before us?

Legislator Gregorius – We should approve The Resolution contingent upon that question being answered before next meeting.

Legislator Terpening – (speaking through the chair) It was a record breaking turnout, approved 605 to 219. There was lots of give and take. They may have made concessions that will be negotiated later.

Legislator Dart – We are still negotiating contracts. There are lots of contingencies and it is difficult to reach parity with different bargaining units.

Legislator Cahill – If we amend the contract, it will have to go to a vote again.

Legislator Gregorius – Our thanks to Legislator Terpening for bringing this contract to a successful conclusion. We will have an informational meeting at 4:00 PM next Wednesday 6/8/08 to determine if the cost of \$1,664,197 includes benefits, etc.

Legislator Gerentine – (to Legislator Provenzano) The small group you are talking about were hired well before 1994 and therefore will have no cost of health benefits when they retire. We still have three more contracts to negotiate and making changes now will have ramifications.

Motion adopted unanimously contingent upon all questions being resolved at information meeting on 6/11/08.

Legislator Lomita – This is a new service that links to the Poughkeepsie Train Station.

Legislator Noonan – Why is there no County cost listed? Legislator Zimet – The town and village of New Paltz as well as SUNY New Paltz asked us to initiate the additional service and they agreed to pick up the County cost as their local share.

Legislator Lomita – The Resolution is contingent upon bus fares being

available and that the operation pass through a bi-monthly review by the Treasurer's Dept.

Attorney Bea Havranek – Whenever a municipality is involved, there must be an Intermunicipal Agreement.

Legislator Provenzano – How do we know that ridership will be as heavy as stated – Where did the figure of \$15,600 come from?

Legislator Lomita – Requested that County Administrator's Office get information on fares from Cynthia Ruiz.

Legislator Gerentine – What if the Treasurer's review finds the run is not worthwhile?

Attorney Bea Havranek – We will write up the parameters in the Intermunicipal Agreement.

Legislator Lomita – There is a 25% local match which should be \$7,500 of \$30,000. The Resolution has to be corrected to read \$7,500 not \$10,000.

Legislator Lomita – It is important to discuss the 2% State cut to programs - we will lose reimbursements in many departments.

County Administrator Mike Hein – The 2% cut for the 2009 Budget had a "clawback" into 2008. This is the first time this has happened. We are working with NYSAC now to determine the net effect. Some programs are hit while others are exempt. We will advise the Legislature of what we feel the total financial impact will be.

Legislator Cummings – We should view the whole impact and not vote on every \$1,800 shortfall.

It was the will of the Committee that they withhold a vote until it is determined if the \$1,800 shortfall in this department will be covered internally.

Legislator Zimet – Proposed that this Resolution should be reviewed by Ways and Means, and Chairman Lomita concurred. It will be reviewed next session (6/11/08).

Legislator Zimet was concerned about refusing revenues – regardless of the source. What is the history of our past revenue sources?

Resolution No. 192 Amending Rules Of Order Of The Ulster County Legislature
To Require A Super-Majority (2/3) Of The Total Vote Of The Legislature To
Carry Any Question, Proposition, Resolution, Motion, Or Any Other Matter
Involving The Granting Of Authority To Increase County Taxes Of Any Kind

County Attorney Bea Havranek – This Resolution has been determined to be Out of Order and cannot be brought forward. This dilutes the power of an elected local official and as such, this action cannot be accomplished by Resolution. By Law only the approved Charter Revisions or Local Law can make these changes. General Municipal Law will not allow it, as it needs a mandating referendum. If we are serious about the intent of the Resolution, it must be advanced as a revision to the Charter next year.

Resolution No. 194 Calling On United States Congress To Implement Energy Incentive Legislation For The Control And Stabilization Of Energy Prices And For The Promotion Of Energy Conservation

Motion offered by Legislator Provenzano, seconded by Legislator Cahill. Legislator Lomita – Gave thanks to Sheldon Quimby for working with Dan Ahouse and Representative Hinchey to assemble a real plan for the future.

Motion adopted unanimously.

Resolution No. 197 Calling For Federal & State Governments To Enact A "Gas

## <u>Tax Holiday" From Memorial Day To Labor Day Each Year And Invest In</u> <u>Developing Alternative Energy Sources To Reduce Future Dependence On Oil</u>

Motion offered by Legislator Cummings in support of Legislator Roberti's Resolution.

There was no second to the motion so the Resolution failed.

Legislator Lomita – Felt that this Resolution was poorly planned as it had an "unknown" financial impact although there is obviously a loss of aid and therefore revenue. There is substantial financial impact.

Legislator Cummings – In defense of Legislator Roberti, the intent of the Resolution was good in that it was an attempt to provide relief for taxpayers.

Legislator Lomita – Considered the Resolution to be out of order, it must be addressed in session as such no vote will be taken.

Legislator Lomita – Informed the Committee that the Resolution must go back to Personnel Committee first and will be reconsidered by Ways and Means next meeting (6/11/08).

Motion to adjourn offered by Legislator Dart, seconded by Legislator Gregorius.
