Legislator Cummings – Questioned if either #335 or #336 had any state clawback potential.

Commissioner Rodriguez – We won't know until it happens but so far no word on it. We will know more after the November emergency session of the Legislature.

Legislator Gregorius – We have little say in the matter, both programs are mandated. We are just transferring funds to cover costs.

Motion offered by Legislator Cummings, seconded by Legislator Zimet.

Legislator Lomita – Had concerns about what the effect of a failure of Ways and Means to approve would have on The Contract.

Atty Havranek – It would have the same impact as on any other Bargaining Unit. They would have to go back to the drawing board. The agreement we are approving has been revised from the original.

Claire Burlingham – She and members of UCCC Administration as well as Atty Bill Wallens crafted the agreement. It follows in essence the approved County Labor contracts.

Legislator Provenzano – It seems we are always in the position of approving things that we know very little about even though we have no objection to it. Perhaps an informational meeting with The College on such matters would be helpful.

Legislator Cahill – In long-term agreements such as this, especially those that require the approval of The Chairman of The Legislature, how will they be affected by the Terms of The Charter?

Atty Havranek – Those agreements in effect will continue but after January, The Executive will give approval.

Motion adopted unanimously.

Resolution No. 344 Repealing, Retroactively To January 1, 2008, Resolution 410 Dated December 6, 2006, Authorizing The County Of Ulster To Charge Back The Towns And The City Of Kingston For The Cost Of Elections Support

Atty Havranek – I am ruling this Resolution out of order. We need a Budget Amendment to amend the 2008 Budget. This Resolution negated Resolution #410 that the Legislature passed last year. We are covering two different issues with two different Budget years. This Resolution does not amend 2008. It has no financial impacts.

Legislator Provenzano – Aren't we mandated to follow a Resolution that we passed and as such the only way to proceed to an amendment is to rescind #410?

Legislator Lomita – Is proposing a Legislative Appeal to resolve the issue. It already cleared the Attorneys.

Legislator Zimet to Legislator Lomita – Is the reason your appeal is appropriate because it does not encompass two Budget years?

Legislator Provenzano – Understands the intent of Legislator Lomita's appeal, but don't we still have to address the Local Law on the books? Ways and Means Committee

Legislator Lomita – The original (#410) Resolution did not separate HAVA expenses from Non-HAVA. We are trying to clean it up to make it more fair for towns, City and County.

Legislator Cummings – The Resolution is on the books and is being presented to towns by Board of Elections - how can we amend it?

Legislator Lomita – Towns and City are up in arms over unexpected HAVA charges that are not covered in their Budgets. The Supervisors all understand what we are attempting to do.

Legislator Provenzano – The County froze its share in 2005; don't we have to repeal it?

Atty Havranek – We are still in 2008 and Resolution does not cover it. It attempts to do 2008 retroactively without financial information.

Legislator Cahill – We only have ten days to get the correct figure and process to the Towns. The Resolution is flawed.

Legislator Noonan – Not all Supervisors were on board. Resolution #410 should be repealed. It is in effect perpetuity.

Atty Havranek – The way #344 is drafted, it is flawed. If your desire is to repeal #410 and then amend the 2008 Budget you have to be specific about costs and then amend 2008.

Legislator Gerentine – Legislator Lomita's amendment will do this. As it is, #410 may not be supportable.

Atty Havranek – Any Resolution binds future Legislatures unless rescinded or modified. The 2008 Budget has to modified.

Legislator Lomita – Last year HAVA was not in full compliance so towns were given a figure based on our situation then. They put money in Budgets to accommodate, but since HAVA was not in there, they were not charged fully.

Legislator Gerentine – Let's put this in place to modify or rescind next week.

Atty Havranek – We still need to know what the intent of the Legislature is. Not comfortable with the dearth of information. What do you intend to do Ways and Means Committee

as a body?

Legislator Lomita – Assigned Legislator Noonan, Art Smith and Attorney Havranek to make modification to the Resolution for consideration next week.

Legislator Cummings – The Town Supervisors and Clerks complained that all powers were taken from them and given to Board of Elections.

Legislator Gregorius - We just met with Supervisors and gave them promises. Whatever we work out cannot renege on those promises. Perhaps we can invite Supervisors to meet again to approve.

Resolution No. 346 Creating A Volunteer Incentive Program (VIP) For Ulster County Emergency Service Volunteers

Attorney Havranek has a concern here with the Resolution as written. There is no Program criteria or details listed. She needs facts to develop and assess before we can put it in Resolution form.

Legislator Dart – Legislator Petit is working on it with Chamber of Commerce in the form of a percentage discount offered to volunteers.

Legislator Zimet – The Program will be implemented through the Chamber, but \$1500 is necessary to pay for the cards involved.

Legislator Dart – The \$1500 will be in the Fire Coordinator's Budget – we can do this as a Resolution in January as a Budget Amendment.

Atty Havranek – If she gets a precise plan, she will work to clean up the Resolution.
