**Resolution Summary:** This resolution would authorize the execution of a contract amendment for professional services on behalf of the Ulster County Department of Information with IBM that will cause the aggregate contract amount to exceed \$50,000.

**Discussion:** Legislator Belfiglio said the questions he had at the last meeting has since been answered by Ms. Wohlfahrt. He discussed his concerns about maintaining "old" 2006 equipment and the fact that the county is "stuck" paying this contract until the equipment can be

phased out and replaced. He suggested that more modern equipment would be much less expensive to purchase and maintain.

The committee had a discussion about the "ballpark" cost comparison to replace and maintain new equipment and how this equipment is used.

**Resolution Summary:** This resolution would authorize the Chairman to execute an agreement with the NYS Division of Criminal Justice Services to fund a Director of Projects for the Intimate Partner Violence Initiative within the office of the Ulster County District Attorney.

**Discussion:** Chairman Gerentine asked for details of how the county ensures that if or when funding ends the position is "sun-setted".

Mr. Carnright discussed how his office envisions this program working to using available data to identify and prevent domestic violence. He explained that such programs have been successful in other areas. This budget neutral two year program will allow his office to work closely with the Probation Department, Social Services and other departments and agencies. After two years they will analyze outcomes to see if the program proves successful in Ulster County and at that point determine if it is worthwhile to continue funding.

Legislator Bartels suggested the District Attorney's office come back to the legislature with an update after one year.

Mr. Carnright welcomed that suggestion and invited members of the Legislature to join him when he announces the program to the public.

The committee discussed the repeating nature of domestic violence and the ability of data to predict individuals who may need additional support so programs can intercede and offer better protection to victims. This program is focused on the offenders and breaking the cycle of abuse.
