<u>SUNY Ulster Budget Presentation</u>: President Alan Roberts and VP of Administrative Services Jamie Capuano

President Roberts and Vice President of Administrative Services Jamie Capuano presented the 2021-22 SUNY Ulster Budget to the committee. Darlene Pfeiffer the top donor for the college over the years was recognized at a dinner for donating 1 million dollars over the years. While celebrating/recognizing Ms. Pfeiffer's generosity, she surprised Dr. Roberts and the group with an additional 1 million-dollar check to support the "President's Challenge Program Scholarship." This donation will be put into an investment to pay for program personnel in perpetuity. One other presentation is planned prior to the Legislative Session.

- No tuition increase and no layoffs solid institution
- Fulltime tuition remains at \$4,880/year
- Part-time tuition will stay at \$190/credit
- Enrollment down 9%
- Federal funding \$4.6 million \$1.3 million of that was allocated to loss revenue which is an allowable use
- County contribution remains just over \$6.4 million
- Enrollment head count 1800, part-time 53%
- 2020 Ranked the #1 community college in NYS
