Resolution Summary: This resolution makes an amendment to a previous resolution associated with the transfer of a Parcel located off North Chodikee Lake Road in the Town of Lloyd from the County of Ulster to the New York State Department of Environmental Conservation for the purchase price of \$178,5000.

Discussion: Chairman Greene summarized a meeting held in the Town of Lloyd on February 23 in which residents of Chodikee Lake Rd expressed concerns about NYSDEC plans for the property. She felt it was a productive meeting.

Legislator Litts shared his concerns and those of his constituents regarding the property lines of this parcel that were not discussed at the February 23 meeting. Legislator Litts reported a meeting he had with the County Attorney. He told the committee that the neighboring residents had survey maps that identified a discrepancy of about 15 feet and felt that the precise property lines should be resolved before the county moves forward with this sale to NYSDEC. He asked the committee to postpone this resolution.

Mr. Rudge assured the committee that once NYSDEC owns the property, surveys would be completed to resolve this issue. He reiterated much of the February 23 discussion in which he assured neighboring property owners he did not feel this site was appropriate for a parking lot.

The committee discussed how the county conducts sales of property for unpaid taxes, the history of this particular parcel and how to proceed.
