Resolutions for the October 18, 2016 Session of the Legislature

**Resolution No. 391**: Setting a Public Hearing on Proposed Local Law No. 14 of 2016 (A Local Law of the County of Ulster for the Regulation of Pet Sellers) to be Held on Tuesday, November 15, 2016 at 6:05 PM

**Resolution Summary:** This resolution sets a public hearing on Tuesday, November 15, 2016 at 6:05 PM to allow the public to offer comments on Proposed Local Law No. 14 of 2016.

## Motion No. 2: Moved to AMEND Proposed Local Law No. 14 to read as follows:

#### **SECTION 2. DEFINITIONS**

4. "Pet Seller" means any person in Ulster County who engages in the sale or offering for sale of more than nine (9) or more dogs or cats ..."

7. "Residential Breeder" means a breeder who sells or offers to sell directly to a Consumer more than fifteen animals per year that ..."

### SECTION 4. RESIDENTIAL BREEDERS – PERMIT REQUIRED

1. It is unlawful for any Residential Breeder to display, offer for sale, sell, barter or exchange for any consideration, any more than fifteen (15) dogs or cats within Ulster County..."

#### **Discussion:**

Chairman Ronk mentioned that the amendments are being proposed to match existing state law as well as for consistency throughout the local law itself.

Legislator Lapp informed the members that he would not be voting for the law as he believed it was redundant as New York State Agricultural & Markets Law and well as the General Business Law Article 35D include regulation of Pet Sellers.

**Resolution No. 444**: Authorizing The Chairman Of The Ulster County Legislature to Execute An Inter-Municipal Agreement With The County Of Oneida For Boarding Inmates At The Central New York Psychiatric Center – Sheriff's Office

**Resolution Summary**: This resolution the Chairman to execute an inter-municipal agreement for inmate boarding services with Oneida County at a rate of \$165/person/day effective January 1, 2017 through December 31, 2019.

Chairman Briggs asked if there was difference between the Onieda County and Monroe County noting that a contract with Monroe County for the same service was approved the previous month. Chairman Briggs expressed his condolences to Sheriff Van Blarcum, Under Sheriff Freer and the entire department for the recent death of Sergeant Winters and complimented them on their handling of the incident as well as the funeral services. Sheriff Van Blarcum thanked Chairman Briggs for attending the services and advised the members that the PBA contract entitles families of officers who die in the line of duty to certain benefits. He added that the correction contract does not include similar benefits. He added that he has reached out to the County Executive to see if there is anything the county can do for the Sergeant's family.

Chairman Briggs asked if there was anything of note in the monthly report. Sheriff responded that it was consistent with previous months.

**Resolution Summary:** This resolution authorized the Chairman to enter into an agreement with the Research Foundation for the State of New York for the purpose of Ulster County's participation in the distribution of Indigent Legal Services Fund, for the period of June 1, 2016 through May 31, 2019 and in the amount of \$185,352.
