### Resolutions for the December 19, 2017, Session of the Legislature

<u>Resolution No. 456</u> – Adopting Proposed Local Law No. 10 Of 2017, A Local Law Amending Local Law No. 7 Of 2008 (A Local Law To Provide For An Exemption From Real Property Taxes For Real Property Owned By Veterans Who Rendered Military Service To The United States During The "Cold War")

**Resolution Summary:** This resolution adopts PLL No. 10 of 2017 amending LL No. 7 of 2008 to grant to honorably discharged veterans, the maximum allowable "Cold War" property tax exemption of 15% of the assessed value, not to exceed \$45K, and for honorably discharged veterans who suffered a service oriented disability, an additional exemption equal to the product of the assessed value multiplied by ½ of the compensation rating of the veteran as determined by Veterans Affairs, not to exceed \$150K and to remain in effect indefinitely or until revoked by Local Law or authorizing State legislation requires a modification.

#### **Discussion:**

Legislator Donaldson provided an overview of the proposed local law whereas this exemption shall remain in effect indefinitely or until such time as it is revoked by Local Law or authorizing State legislation requires a modification. Previous compliance required renewal every 10 years.
