Legislator Rodriguez stated that he would support the grant funding, but said that there are issues in the Sheriff's Office with overtime as well as other things. Chairman Ronk stated that it would be unfair to lump all overtime together and explained that the resolution in front of them is reimbursing for overtime from participation in a multijurisdictional counter-terrorism exercise.
