### **Discussion:**

Legislator Loughran stated that he would be scheduling an informational meeting on the law later in the month. Legislator R. Parete said that he was frustrated that there has been a campaign finance law introduced for more than two years and there was no attempt to try to work on that law before introducing this one. He added that he was concerned that the law permits contractors who do business with the county to contribute to campaigns. He also took issue with the makeup of the

oversight committee as well as some of the public financing components. Legislator Donaldson commented that the concept was correct, but the Legislature should take their time to go over the law. He suggested forming a sub-committee to review the law. Legislator Rodriguez said he was more than willing to serve on a sub-committee to review the law.

### Discussion:

Chairman Ronk stated that he did not feel that the Resolutions were ready for adoption. He expressed concerns with parts of the law which included portions of the Westchester County law which did not apply to Ulster County, the amount of the fines, and the qualifications of the Human Rights Commission members. He suggested a subcommittee might be a productive mechanism to review the law. Chairman Roberts suggested that Chairman Ronk appoint a committee to review the law.

Legislator Rodriguez expressed his frustration with how long the law has been discussed. Legislator Donaldson stated that he was open to changes to the law which protected peoples' civil rights as long as there are also protections for people who are wrongfully accused. Legislator Belfiglio commented that during the public hearing a few members of the Human Rights Commission spoke about the need to more adequately fund the Commission for them to be able to enforce the provisions of the law. Chairman Ronk requested that the Chair of the Human Rights Commission be included in any notifications regarding meetings or discussions on the laws. Chairman Roberts asked if there were any volunteers to serve on the subcommittee. He appointed Legislators Loughran, R. Parete and Rodriguez.

He informed the members that the law as written does not offer equal treatment, rather creates a super protected class. He recommended amending the law to read in the form attached.

The members discussed the proposed amendments and asked Legislator Berky if she, as the sponsor, would accept them. Legislator Berky responded that she worked closely with members of the LGBTQ community and other stakeholders and did not feel she could agree to any changes to the law without first consulting them.
