#### **PRESENTATIONS:**

Chairwoman Tracey Bartels called upon Legislator Kathy Nolan, District No. 22, to present a Pride of Ulster County Award to Maraleen Manos-Jones of Shokan. Ms. Manos-Jones was recognized for her decades of local, regional, and international work raising awareness of the importance of promoting and protecting butterflies and other pollinator species through her writing and community pollinator garden initiatives. Joining Maraleen was her husband, Steve.

Chairwoman Tracey Bartels called upon Legislator Kathy Nolan, District No. 22, to present a Pride of Ulster County Award to Che Spiotta of Boiceville. Mr. Spiotta was recognized for earning the coveted title of Master Chef by winning Season 7 of the internationally acclaimed cooking competition, *MasterChef Junior*<sup>TM</sup>. Joining Che was his mother Elizabeth, and brothers Jakson, Cosimo and friend Robert.

#### **PUBLIC COMMENT:**

There were (7) speakers signed up for public comment.

- 1. <u>Paul Fowler, Saugerties</u>: Mr. Fowler spoke in favor of the Legislative support and good work of our local libraries and the benefit to Ulster County residents. He also spoke about Fowler Advocacy's work fighting drugs in his community.
- 2. <u>Leeanne Thornton, Saugerties</u>: Ms. Thornton, Deputy Supervisor for the Town of Saugerties, spoke in support of Resolution No. 379 to ensure other municipalities and residents are safeguarded from the extensive legal process Saugerties is dealing with. Ms. Thornton also suggested the County purchase a water chestnut harvester creating a shared service among municipalities along the Hudson River to address the invasive species.
- 3. <u>Callie Jayne, Kingston</u>: Ms. Jayne is the Executive Director of Rise Up Kingston who opposes the Kingstonian Project. Ms. Jayne spoke to the need for safe, stable and affordable housing in Ulster County.
- 4. <u>Lisa Boudreau</u>, <u>Kingston</u>: Ms. Boudreau with Rise Up Kingston spoke on behalf of numerous organizations opposing the Kingstonian Project and against awarding the developers additional tax incentives.
- 5. Lisa Royer, Kingston: Ms. Royer signed up to speak however reconsidered.
- 6. <u>Iris Marie Bloom, Marbletown & Stone Ridge</u>: Ms. Bloom spoke in support of Rise Up Kingston and pollinator Resolution No. 375. Also noting the proposed straw law is a probusiness initiative.
- 7. Kate Reese Hurd, High Falls: Ms. Hurd spoke to climate change, solar arrays, and 5G radiation.



The Swamping of Earth's Electromagnetic Field EMF and Biosphere with Human-Generated EMFs



IN LIGHT OF all of the issues surrounding global warming and escalating climate havoc, one factor that needs to be looked at is the unprecedented introduction of wireless transmissions into the workings of the earth's electromagnetic field system. To review, this natural EMF system depends upon: the earth's magnetic field, the sun's solar wind radiation, the fields of the ionosphere and the Van Allen belt, the day/night pattern of the sun and moon, the moon's gravitational action, and, the ever-changing atmospheric phenomena (the sferies) that generate electromagnetic radiation.<sup>1</sup>

We now consider it normal to keep devices and electronics churning out WiFi and EMFs 24/7. Our charging cords, adapters and other equipment also generate electromagnetic fields even when not in use and when technically off, just to save us a few moments of start up time. Cellphones emit WiFi as intermediary cell-towers for other users when we think we've shut them off. And every routine ping to a cell-tower or repeater triggers needless radiation into the environs. We even recharge wirelessly now.

But what must be the cost of our artificial creation of electromagnetic radiation, as WiFi and as EMFs, beyond the cost of the impacts of these radiations on our health? The chart below shows that for every unit of electrical energy consumed at the end point, up to 90% of the source energy will be wasted, depending on the source, application and degree of efficiency at all points along the way. In terms of electrical power supplied by burning fossil fuels and by all other energy sources (none of which are so very clean all things considered – solar panels create large amounts of hazardous Dirty Electricity EMFs), the collective waste is huge. Then we can see that both directly (via human-made artificial EMF radiation) and indirectly (via the waste of energy), the disruption of the earth's normal electromagnetic and atmospheric systems is well-nigh guaranteed.

We would be wise to downsize and shut off all WiFi/EMF sources as much as possible, design devices and electronics to permit easy, complete power-down. 
